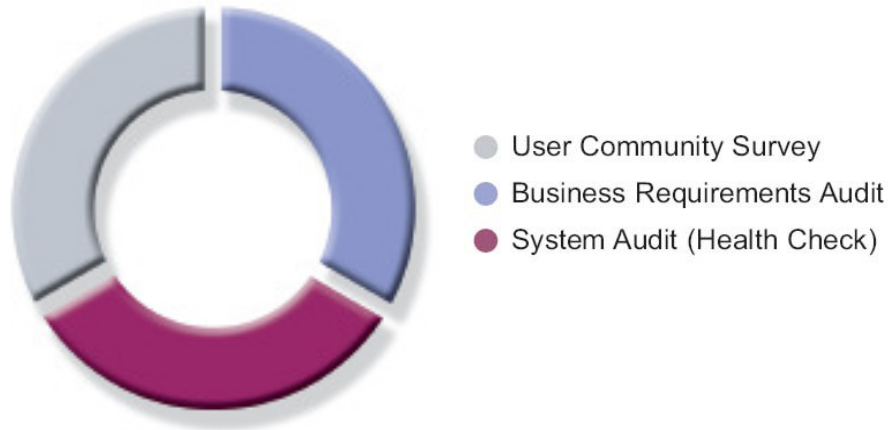

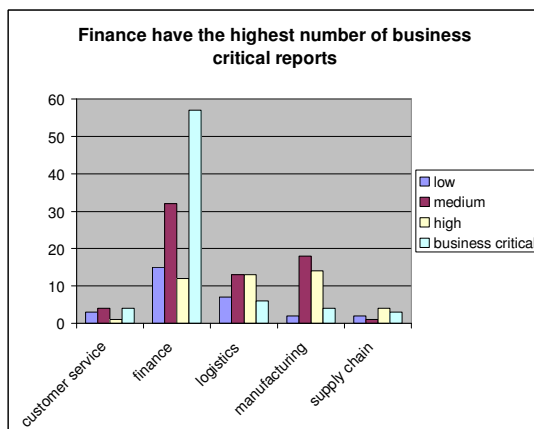
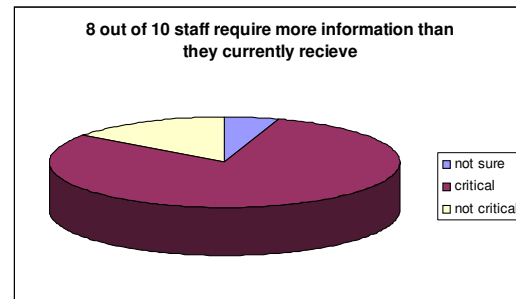
The CSI provides a clear view of how well your Business Intelligence and Management Information Systems meet the needs of your business.



In addition they identify areas for improvement and provide a basis for any future comparison. There are three key elements which can be taken separately or form one cohesive process.

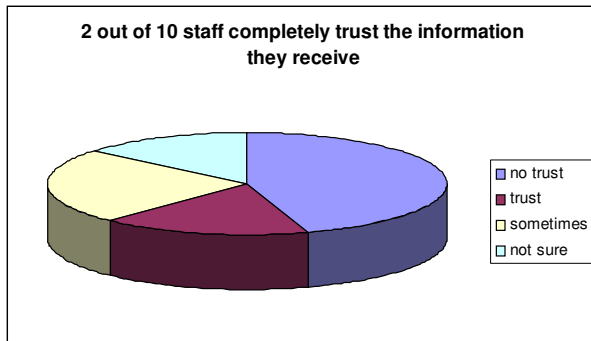
User Community Survey

A fixed price analysis which is comprised of a company specific questionnaire (survey) that delivers analysed findings in a summary presentation for management review. This provides a cost effective, quick assessment of how well the systems are received by the business and identifies trends, issues, concerns and perceived value.



Business Requirements Audit

An interview based process involving the principle power-users to ensure clear and detailed understanding of the system requirements and to determine how well their needs are currently met. This process delivers granular information about how well the user requirements are met and will provide recommendations of improvements.



System Audit (Health Check)

This element focuses on the deployment of the system itself – architecture, resilience, use of best practice, system efficiency, license deployment, security, report library, report utilisation. The report summarises the health of the system and provides recommendations of enhancements and developments.
